Innovations in Teaching

2008 – Computer Information Technology students are exposed to multiple technologies during their tenure at WKU, including database, critical thinking, multiple operating systems and webpage design. However, until Casegrader was introduced in CIT300, the students did not receive any spreadsheet analysis, design, or problem-solving. I have created tutorial videos for each case that introduces the student to the specific case objectives.

2008 – This hybrid approach caused an abundance of videos to be created for the student to practice and attempt to master spreadsheet design and problem-solving. The videos were created using like-data allowing the student to watch, learn, and then create.

2008 – Computer Applications-Students were given a sample video of using spreadsheets to analyze business opportunities.

Video from the desktop. I was diligent in using ITV to bring the information to students from multiple WKU campuses. Being first in line to accomplish this allowed me to develop a rapport with the ITV personnel @ WKU to help establish and ensure success for the upcoming classes in Systems Management from the other WKU faculty members in our department.

2008 – This Interactive Television (ITV) course was delivered to all extended WKU campuses with the same rigor and expectations as the SM300 face to face class. This required additional correspondence, mentoring, and testing to ensure this compliance.

2008 – This course was selected by the Gordon Ford College of Business Dean and Associate Dean to comply with the AACSB requirement to pre-test students in presentation skills. Video/audio equipment was setup

and each student was recorded for 5 minutes. This recording was graded and aggregated with other students from this class and another class to provide the pre-testing data.
