"Enhancing Returns in a Volatile Global Stock Market: A Time Limited Approach to Risk and Reward" (Writing Results), International Journal of Global Business and Economics
The recent shocks in the financial markets and declines of the stock markets around the

world have caused many traditional investors to question the wisdom of a Buy and Hold Strategy (BHS). While the BHS is an approach that many investment advisors promote, the authors believe that by investing in the Dow Jones Industrial Average (DJIA) only during certain months of the year, risk exposure and reward can be superior to that of the (BHS). This paper empirically examines the DJIA using a seasonality approach. Seasonality is not unique to the DJIA; the literature review indicates that it exists in other stock markets around the world. This paper attempts to answer the question: Is there a significant difference between using the buy and hold strategy and a seasonality strategy? Other research questions involving different time-sensitive investment strategies are explored.
